Please carefully read the policies and conditions below.</p> <ul style="list-style-type: none"> - Bar passes will be sold starting at 9:30AM on Thursday, May 17, 2012. - No more than 150 bar passes will be sold. - Bar Passes will be sold only during regular reference desk hours. The charge for the Reader's Pass is \$50, except for graduates of law schools that charge more than \$50 for summer access for NYLS students.
